

## Winter Resolution 2019 Sweepstakes

### OFFICIAL RULES

**No purchase, obligation or transaction necessary TO ENTER THE SWEEPSTAKES.**

**Promotion Period:** Winter Resolution 2019 ("Sweepstakes") begins January 1, 2019 and ends February 28, 2019. Entries received prior to or after the Promotion Period are not eligible for the Sweepstakes.

**How to Enter:** Individuals will receive an automatic entry into the Sweepstakes when they log into Hawaiian Financial Federal Credit Union's MyFinancial between January 1, 2019 and ends February 28, 2019, and have added at least one Goal. One entry per household.
